#### **GENERAL CONDITIONS**

- 1. Tugs are to be ordered by phone as specified above.
- 2. Additional tugboat must be ordered a minimum of 10 hours in advance.
- 3. When "Magnus" or "Ägir" serves as second tug, a fixed price of SEK 68 117 will apply.
- 4. Cancellation or alteration of time for arrival or departure will be charged as follows;
  - a) within 2-5 hours prior to time ordered for the assignment 30% of actual rate
  - b) later than 2 hours prior to the time ordered for the assignment 50% of actual rate
  - c) after tug/tugs have left its berth place 100% of actual rate, and mob/demob charges for second tug if applicable.
- 5. When tugboat "Magnus" or "Ägir" have been ordered for an assignment and then being cancelled later than 15.30 hours day before Saturday, Sunday or holiday, 50% of valid rate will be charged.
- 6. Tug standing by and time exceeding 30 minutes after ordered time will be charged by SEK 6 090 and commenced hour.
- 7. Shifting within the harbor area is to be considered as a new assignment and charged subsequently.
- 8. External tugs provided by Hallands Hamnar AB as additional tug or as a substitute for "Magnus" or "Ägir", if they are not at disposal, will be invoiced by the actual costs charged by the tugboat provider with a 10% surcharge.
- 9. For towing of vessel not using its main engine, there is a surcharge of 30 %.

#### **SPECIAL CONDITIONS**

- 10. Assistance exceeding 2 hours is subject to a surcharge of SEK 6 090 per beginning of new hour following until the assignment is completed.
- 11. All towage is undertaken subject to the Scandinavian Tug owner's Association's compulsory standard towage conditions of 1959, revised 1974. (See page 6).
- 4. and 8. will also apply in case of fog, storm and ice. In case of war, strike, lockout or during extraordinary weather-conditions rates to be charged according to circumstances.

#### **RATES, NORMAL WORKING HOURS**

To be charged until further notice for inward or outward towage within the harbor area of Varberg or Halmstad, provided there is no hindrance from ice and the vessel is not aground or has suffered average.

The towage rates are mainly valid for ships to load or discharge cargo by Hallands Hamnar AB. Quotations are made for other commissions.

#### **GENERAL CONDITIONS**

- 2. Cancellation or alteration of time for arrival or departure will be charged as follows;
  - a) within 2-5 hours prior to time ordered for the assignment 30% of actual rate
  - b) later than 2 hours prior to the time ordered for the assignment 50% of actual rate
  - c) after tug/tugs have left its berth place 100% of actual rate, and mob/demob charges for second tug if applicable.

## SCANDINAVIAN TUGOWNERS ASSOCIATION'S COMPULSORY STANDARD TOWAGE CONDITIONS OF THE YEAR 1959, REVISED 1974 AND 1985.

The tugboat enterprise (hereinafter called the Company) provides towage services on the following conditions.

#### 1. DEFINITIONS

The expression Hirer in these conditions means the body or person who has ordered the service or on whose behalf the service has been ordered.

The expression damage in these conditions means economical losses of all kinds including but not limited to total loss, damage, loss of income and expenses and also loss of and damage to cargo on board of the vessel in tow.

#### 2. THE COMPANY'S LIABILITY TOWARDS THE HIRER

The Company is not liable for damage caused to the Hirer in connection with the towage service unless the damage is a consequence of fault or neglect on the part of the Company's management. The Company is, however not liable for fault or neglect by a person of the Company's management committed in such a person capacity of master of a tug or member of its crew.

The Hirer is nor in any case entitled to damages from a master of a tug, a member of its crew, a pilot or anybody else in the service of the Company.

The liability of the Company shall in any case not exceed 100 000:- SEK.

#### 3. THE HIRER'S LIABILITY TOWARDS THE COMPANY

The Hirer shall indemnify the Company for all damage caused to the Company in connection with the towage service unless the Hirer shows that neither the Hirer nor somebody for whose acts the Hirer is liable totally or partly has caused the damage by fault or neglect.

Should the Company be held liable for damage caused to a third part in connection with the towage service, the Hirer shall indemnify the Company unless the Company would have been liable toward the Hirer in case the damage had been suffered by the Hirer.

In case of dispute, The Danish, respectively the Norwegian, respectively the Swedish text shall apply.
